## ATTENTION CONTACT LENS PATIENTS

You will have two charges as a contact lens wearer: your doctor's fee for his/her services, and a materials fee for the contact lenses. The doctor's fee includes your eye examination fee plus your contact lens evaluation and management fee, which is a yearly service fee for contact lens vision and eye health management that is independent of how long you've worn contacts, how often you wear your contacts or where you purchase your lenses. [some offices combine the doctor and material fees together and call it a "Contact Lens Exam Fee"]. Contact lens materials are charged of course only when you need to purchase a new supply of lenses.

You will be given a Contact Lens Care Program form at your exam, completely detailing your charges for your doctor's fees and materials fees. This form will also give details of your rebates and discounts, with a total of your out-of-pocket fees and overall yearly costs for contact lens wear. PLEASE ask if you have questions!

We offer substantial savings on the following when you purchase your yearly supply of contact lenses from us:

- Backup eyewear to contact lens wear
- Sunglasses [prescription or non-prescription]

Our staff will review all of the above with you at your exam, but please feel free to call and discuss any questions with us before, or of course during, your visit.

## infantSEE PROGRAM

The first eye examination is now recommended at the age of six months. This is to rule out eye conditions and diseases such as amblyopia (lazy eye), crossed and wall eyes (strabismus), juvenile glaucoma and cataracts, and retinoblastoma (eye tumor of children) which usually CANNOT be seen by the pediatrician or the parent.

We participate in the nationwide **infantSEE** program. Under this program, we agree to:

- Examine infants and preschoolers for their first eye exam at no cost to the parent/guardian.
- Provide a comprehensive, dilated eye examination (not just a screening as is done in the pediatrician's office)
- Provide this to any child no matter the status of the parents at our office (they don't have to be our patients).
- Include children up to the age of kindergarten in this program.
- Please note: if you schedule an appointment and don't cancel within 24 hours, you forfeit this free exam.
